

## **COMMUNITY NEWS - STOP SCAMS!**

# SPOT SCAME STOP AND SAY NO

### RUE#1 Don't be afraid to say NO!

- Say NO, hang up, and get some advice
- · Say NO until you have received all information in writing.
- Say NO and explain that you would like to speak to a lawyer of your choice before
  agreeing to pay government "fines" or "fees."
- Never be bullied into agreeing with the caller without further information and don't provide further information to them.

### RULE#2 If it sounds too good to be true... it probably is

If the person contacting you is offering you an easy way out of a fine or fee, or is
offering something that is too good to be true... it probably is. If you have doubt
contact a friend a family member or your 'ocal police for advice.

## RUE#3 Do your research

 Always verify that the organization you're dealing with is legitimate before you take any other action

### RUE#4 Don't give out your personal information

Beware of unsolicited calls where the caller asks you for personal information

### RULE#5 Beware of upfront fees

Many scams request that you pay fees in advance of receiving goods or a prize.
 They may even pressure you into making a payment as quickly as possible to solve a legal problem or hold an item. If someone is asking you for upfront payments this should immediately raise a RED FLAG for you.

### RULE#6 Protect your computer

- Watch out for urgent-looking messages that pop up while you're browsing online. Don't click on them or call the number they provide
- No legitimate company will call and claim your computer is infected with a virus
- Make sure you have anti-virus software installed and keep your operating system up to date
- Never give anyone remote access to your computer. If you are having problems with your system, bring it to a local technician

### RUE#7 Protect your online accounts

Create a strong password by:

- Using a minimum of 8 characters including upper and lower case letters, and at least 1 number and a symbol
- Creating unique passwords for every online account including social networks, emails, financial and other accounts
- Using a combination of passphrases that are easy for you to remember but hard for others to guess
- · Enable multi-factor authentication
- Only log into your accounts from trusted sources
- Don't reveal personal information over social media
- ENSURE YOU ARE USING THE HIGHEST SECURITY SETTINGS WHEN USING SOCIAL MEDIA

You only need to submit a new application if your information has changed. Changes can include:

- Bank Account Info (if requesting direct deposit)
- · Or if you have recently turned 19



# Indigenous Summer Internship Program: Marine Spill Response Technician

Western Canada Marine Response Corporation (WCMRC) is a Transport Canada certified Response Organization, whose mandate is to ensure there is a state of preparedness in place and to minimize the impact when an oil spill occurs. This includes the protection of wildlife, cultural and environmental sensitivities, and the safety of both the responders and the public.

#### **How it Works**

WCMRC is hiring Indigenous Interns to work as a deckhand at each of our six response bases – Burnaby, Nanaimo, Sidney, Beecher Bay, Port Alberni and Prince Rupert. The four month (May – August) summer job is a full-time paid position.

Interns will gain valuable work experience in the marine sector and insight into how spill response works on Canada's West Coast.

### Who is Eligible?

Applicants should have a high school diploma and a valid driver's license. Small Vessel Operator Proficiency (SVOP), Marine Emergency Duties (MED A1/A3) certificate and Radio Operators Certificate (ROC- M) are considered assets. Candidates should be physically fit for work at sea in calm and rough waters. You must also be willing and able to work outdoors in extreme weather conditions.

Those wishing to apply must be Indigenous (First Nations status or non-status, Métis, Inuit).

The Health and Safety of our employees is always our #1 priority, therefore WCMRC requires all interns to be fully vaccinated against Covid-19.

## **EMPLOYMENT NEWS**



#### **PURPOSE OF THE POSITION**

The Fisheries Manager will be responsible for coordinating all aspects of fisheries management, fish habitat restoration and enhancement, and work to increase community participation in fisheries related activities.

### **DUTIES AND RESPONSIBILITIES**

- · Conduct community based domestic fishing as required.
- Work with other staff/volunteers and DFO staff to implement catch monitoring activities that are appropriate to meet management requirements of the species or species groups.
- Ensure all Fisheries activities are conducted in safe and appropriate conditions.
- Maintain all Fisheries related equipment in good working condition.
- Implement assessment activities necessary to support domestic fishing activities for Tsawout members.
- Salmon habitat restoration and salmon rebuilding activities in Tsawout territories.
- Implement appropriate assessment activities to properly evaluate fisheries restoration and salmon rebuilding activities.
- Attend various fisheries management and technical meetings, training courses, as required or as directed by the Band Manager.
- Conduct themselves in a professional and respectful manner.
- Maintain confidentiality on all matters relating to the affairs of the Tsawout First Nation.
- Perform other duties and responsibilities as necessary in the performance of the position and as assigned by the Band Manager.
- Boating and navigational skills.
- Knowledge of water, fisheries, environmental and resource planning principles and practices.
- Well-organized and makes good use of systems to track tasks, schedules, etc.
- Strong oral and written communication skills.
- Knowledge of general office procedures and operation, including photocopier and computer skills.
- Working knowledge of Microsoft Office Word and Outlook. Familiarity with Excel, PowerPoint, and Publisher are assets, or willingness to learn.
- Ability to maintain good office systems, including electronic file management and use of online systems such as DropBox.
- Criminal Record Check is a condition of employment.

### NOTICE TO ALL CLIENTS ON INCOME ASSISTANCE

<u>Please ensure that declarations and all supporting documents are in by the 15<sup>th</sup> of every month.</u> All declarations require applicant signature and, if applicable, it <u>must</u> include spouse signature, job search form, hydro and phone bill (if eligible), most recent paystubs and bank statements, if required.

\*\* NO DECLARATION (paystubs, job search) = NO CHEQUE \*\*

<u>Cheque issue is the last Wednesday of every month.</u> Cheques are available for pick up between 9 am to noon and 1 pm to 4 pm. No calls are taken on cheque day and no one can pick up someone else's S/A cheque unless that person is seriously ill, has mobility barriers or other extenuating circumstances.

Clients who submit their documents AFTER the deadline date can pick up their cheque on the following Friday.

Clients who need to update their file or apply for S/A need to book an appointment between Tues. to Thurs.

### NOTICE TO ALL EMPLOYABLE CLIENTS

It is <u>MANDATORY</u> that all employable people seek employment. According to Social Development Policy 2.2: Termination of Benefits – Refusal or abandonment of employment opportunities, refusal to participate in an appropriate training or education opportunity or rehabilitation program will result in Social Development closing your file.

Failure to show any effort in seeking employment or education opportunities such as job searching, employment workshops or upgrading - will result with your SA file being closed. Whenever a decision is made to terminate client benefits, the client has a right to appeal the decision to Aboriginal Affairs and Northern Development Canada by picking up an administrative review form from Social Development. Thank you.

### Tsawout Social Development (SD) – Income Assistance Application Process

# <u>STEP 1</u> – OBTAIN APPLICATION FROM TSAWOUT RECEPTION TO MAKE AN APPOINTMENT.

# NO APPOINTMENTS WILL BE MADE A WEEK PRIOR TO OR DURING THE WEEK OF CHEQUE ISSUE.

- Complete Social Assistance Application Package
- Identification Adults 2 each (1 must be a photo)
- Identification Children 1 each
- Verification of Income 60 day bank statements, pay stubs, 2 most recent pay stubs, El Income and Spousal Support
- Utility Bills BC Hydro, phone bill, gas or oil bill
- Tenancy Agreement Tsawout Social Housing, CMHC documents or mortgage documents
- Privately Owned Homes proof of ownership documentation
- Tax Forms Canada Child Benefit, Notice of Assessment
- · Other Supporting Documents

### STEP 2 - INTAKE APPOINTMENT

- Bring all supporting documents to your appointment
- If you have a spouse, he/she needs to be present to sign all documentation
- Employable clients are required to discuss a plan to obtain employment or have an education plan to attain further skills that will help you gain employment.
- If you are unable to seek employment, the worker will need a
  medical note that will temporarily excuse you from seeking
  employment or until you are eligible to apply for PPMB
  (Person wil Persistent Multiple Barriers) or PWD (Person with
  Disability) designation.

#### STEP 3 - PROCESSING

- Allow up to 5-7 business days for application approval.
- Worker will notify you of your eligibility for Income Assistance.
- We understand that you are in need of help and your matters are important to us. We are doing due diligence to ensure that the process is completed in a timely mannter. We appreciate your patience.

# STEP 4 - YOU HAVE BEEN CONTACTED TO INFORM YOU OF YOUR ELIBILITY STATUS

- Approved Applicants Will now have the responsibility to assure that all documentation (Declaration, utility bills, pay stubs, job search or any other required documents) is submitted by the 15<sup>th</sup> of each month to ensure they receive their entitlement on time. ALL clients have a responsibility.
- Ineligible Applicants Varies on the situation.
- Will have an opportunity to gather missing or additional supporting documents.
- If you are eligible for El or in receipt of El, you will not be eligible for Income Assistance.
- You have earned income that is more than what you are eligible to receive, then you have to wait 30 days to reapply.
- If applicant does not agree with the decision, the applicant can appeal the decision – Inquire about this process with the Social Development Worker.

**Carbage pick-up (once/week)** If your garbage is missed or not picked up, call BFI directly at 250-652-4414. **Compost (Bi-weekly)** If your compost is missed or not picked up, call Refuse at 250-381-6007. If called the same day or early the next day, it is possible to have it picked up the same week if they are in the area and they will ask you to have it at the end of the driveway by 7 am on whichever date they advise. If not, it will have to wait until the next regular pick-up date.

**Recycle (Bi-weekly)** If your recycle is missed or not picked up, call Emterra at 250-385-4399. Call by 11:00 am the next day and they can probably do a pick-up. If any later, it would have to wait until the next pick-up date.

Reminder that the Heavy Garbage Program has ended. Please do not leave heavy garbage on the side of the road. We continue to clean up the dumpsite on Longhouse Road from the previous years programs. Please discard your heavy garbage at local metal recycle or Hartland landfill.
