### **VNFC Properties - Housing Application**

Victoria Native Friendship Centre welcomes Indigenous families, elders, individuals, and students to a place to call home in a safe and healthy community complex. Fernwood House is located at 1321 Fernwood Road and has 8 self-contained, 2-bedroom units. Siem Lelum is located at 120 Gorge Road East and has 41 self-contained suites, ranging from studios to 3-bedroom units. Salish Sea House is located at 7611 Central Saanich Road and has 28 self-contained units ranging from 2-bedroom units to 3-bedroom units, and one accessible 2-bedroom unit. Salish Sea House is workforce housing; the family income must not exceed the Housing Income Limits (HILS) and meet affordability standards of rental housing costs not exceeding 30% of income.

### **A Few Important Guidelines**

- **Fill in all required information; only completed applications will be considered.**
- No pets allowed on any of our properties.
- No drugs or smoking of any combustibles allowed on the premises at any time. No alcohol consumption in any common areas and no parties that will disturb the quiet enjoyment of other tenants.
- All adults must complete the Gimme Shelter Program (Salish Sea House requirement) alternatively BC Rent Smart online free program. (Certificate must be attached for application to be accepted)
- All youth (19-25) must work or attend school.
- There is parking on all Properties (Fernwood House and Siem Lelum have limited parking).
- One guest may stay for a total of 14 days in a calendar year.
- Fernwood House and Siem Lelum have coin-operated laundry facilities. Salish Sea House has in-suite laundry.

VNFC Properties must adhere to the **National Occupancy Standards** when considering a household composition for units when they become available. These guidelines are:

- There shall be no more than 2 or less than 1 person per bedroom.
- Spouses and couples share a bedroom.
- Parents do not share a bedroom with children.
- Dependents aged 18 or more do not share a bedroom.
- Dependents aged 5 or more of opposite sex do not share a bedroom.

The following guidelines are used when applying the National Occupancy Standards:

- Couples (two individuals) are only eligible to apply for one-bedroom units, as they would be under-housed in a studio unit.
- In recognition of a variety of co-parenting arrangements, a dependent child who resides with their parent(s) a minimum of 40 percent of the time will qualify as a permanent member of the household when determining eligibility and appropriate unit size.
- We understand families have children share bedrooms, however, we are required to adhere to National Occupancy Standards.
